**Notification:** Last parliament meeting of this calendar year hence the last meeting consisting of these MPs.

\$	Matter	Description
1.	PDMI	The president declares the meeting to be initiated.
2.	Election of chairperson	The ordinary chairperson August Lindberg is unable to attend this meeting and since no alternate chairperson is elected, one person needs to be elected for this meeting.
		SUGGESTION to elect a stand-in chairperson for the meeting.
3.	Adjustment of Electoral Register	The secretary will call out the names of the parliament members. According to LUNA's constitution, at least eight (8) of its members have to be present for the parliament to be allowed to make formal decisions.
		SUGGESTION to adjust the Electoral Register according to above.
4.	Rules of notification of the meeting	According to LUNA's constitution, a notification should be sent out no later than 15 weekdays before the meeting.
		SUGGESTION to approve that the notification of the meeting was done in a timely manner.
5.	Approval of the agenda	If any matters are to be added or removed from the agenda, or changed in any way, it is to be done now. To add a matter of decision, at least 75% of the parliament have to vote in favor; to add a matter of discussion, at least 50%.
		SUGGESTION to approve of the agenda.

6. Election of adjusters

Traditionally, there are two (2) adjusters at meetings of the parliament. Together with the chairperson, the two check the minutes for errors, and approve of the minutes if there are non.

#### SUGGESTION

to elect two (2) adjusters for the meeting.

7. Co-options

If anyone is present who is not either a member of parliament or permanently co-opted, that person has to be given temporary right to be present and to speak at the meeting. A person may also be given temporary right to make motions, but this is rare. A list will be passed around, and anyone wishing to be given temporary rights as described above should sign this list.

#### **SUGGESTION**

to allow co-options according to the list.

8. Approval of previous minutes Attachments: Att\_1a-d Minutes from previous parliament meetings are yet to be approved. Please view the attached documents.

Minutes from meeting 7 (2016-10-19) and 8 (2016-11-16) are yet to be approved.

Last parliament meeting discussion point §11 was made into a decision point (att\_1b) which goes against §6.9.4 and §14.2 in the statutes. One student council raised awareness of this issue afterwards and the board, backed by the inspector and auditor proposes changes to the protocol according to attached board proposition (att\_1c).
